### New Business

**Public Hearing: Public hearing on “Ordinance Restricting Vehicle Weight on Posted Ways”** – Public Hearing opened at 6:32pm – Mr. Lyons was in the audience at the request of the Board to explain the difference between a Title 29 and Title 30 Road Ordinance. Under a Title 30-A, section 3009 the Selectboard may close a town road any time during the year they feel there is a public safety issue and there has to be substantial documentation and proof of the safety issue, whereas a Title 29 ordinance is more a seasonal closure authority. Also, under a Title 30-A ordinance a business situated on a closed/restricted road may petition the Board for a permit for use and provide a bond for that use and any damage done under that permit. Public hearing closed at 7:02pm. *Motion by Jack Bridges to approve the Title 30-A ordinance as written, no second, motion failed.*

**Public Hearing: Public hearing on liquor license renewal for Nodd-Inn, LLC d/b/a Crocker House Country Inn.** Public Hearing opened at 7:03pm, no public comment, public hearing closed at 7:04pm. *Motion to approve the liquor license renewal for Nodd-Inn, LLC d/b/a Crocker House by Sean Jones, second by Adam Foster, passed 4/0.*

**Public Hearing: Public hearing on liquor license renewal for Iron Bound Public House d/b/a Iron Bound.** Public Hearing opened at 7:05 pm, no public comment, public hearing closed at 7:06pm. *Motion to approve the liquor license renewal for Iron Bound by Sean Jones, second by Adam Foster, passed 4/0.*
